KYMENLAAKSON SÄHKÖ'S TERMS OF USE FOR ELECTRONIC SERVICES

1. General

Welcome to the electronic services (hereinafter "Service" or "Services") of Kymenlaakson Sähkö Oy and/or its subsidiary (hereinafter "Kymenlaakson Sähköverkko Oy"). The services include Kymenlaakson Sähkö Oy's web pages and the oma-KSOY service. We request that you read the following terms of use (hereinafter "Terms of Use") carefully before using the Services.

By using the Service, the user (hereinafter "User") accepts and agrees to comply with the Terms of Use in force at any given time. The provision of each Service is the responsibility of the company within the Kymenlaakson Sähkö Oy group that has been indicated to provide the Service in question or that, based on a contract or actual implementation, provides the Service in question.

2. Using the Services

The information published on Kymenlaakson Sähkö Oy's website is open to all. Using other Services may require registration, and some of these Services may only be directed at customers using Kymenlaakson Sähköverkko Oy's online service.

A User registering for the Services must be legally competent and identify themselves using strong authentication. Case-specific exceptions must be agreed separately with Kymenlaakson Sähkö Oy. Upon registration, the User is obliged to provide the information requested on the registration form. The User shall ensure the accuracy of this information.

After authentication, a username and password can be created for the User, which shall be stored carefully and shall not be handed over or disclosed to others. Logging into the Services enables numerous functionalities, such as the ability to edit information, control the functions of the measuring device and order work. Users who discover that their login information has been obtained by a third party shall immediately notify Kymenlaakson Sähkö Oy's customer service (asiakaspalvelu@ksoy.fi).

Use of some Services may require downloading separate software or icons. Using the software or utilising all of its features may require the User to accept the sending of notifications and/or messages through the software, and/or to allow the use of cookies or other possible analytics tools. Furthermore, the functionality of the Services may depend on technical factors, such as the speed or functionality of network connections. Kymenlaakson Sähkö Oy reserves the right to terminate the use of the Services due to maintenance or update work, for example. The aim is to provide notification of any outages in advance, whenever possible.

The services may only be used for their intended purposes. The User may not in any way interfere with the operation of the Services or the ability of other Users to access the Services. It is prohibited to install machine-reading robots or other automated monitoring systems, send spam or other unauthorised

communications, and engage in other activities that are contrary to the intended use of the Services. If necessary, Kymenlaakson Sähkö Oy has the right to restrict the use of electronic services.
